




- Total 109 participants from all over Pakistan
- Mostly graduates from year 2013 onwards











Publications in the indexed journals







Those who replied 'YES' average number of publications was 2 and only seven respondents(18.0%) had 5 or more publications.

Experience with clinical Audits or QIPs










70.0% opted for UK and remaining were mix of USA , Australia , Canada and Gulf countries



Agreed action points after panelists discussion

- 1. One clinical audit each year to be made COMPULSORY for trainees.
- 2. Trainees should submit an AUDIT of 50 cataract surgeries performed by them during the training and must include information on risk factors , any complications and outcome data(VA and refraction).
- 3. MINIMUM number of phacocataract surgeries to be set (likely 100).
- 4. Private institutions to COLLABORATE with other teaching hospitals to assist trainees achieve this number.
- 5. BPOS will facilitate in Audit and Research development including ORGANIZING courses for trainers.
- 6. BPOS will facilitate interested doctors for their SUBSPECIALTY training to come to UK through dual sponsorship and IMT programs.
- 7. BPOS ,CPSP and OSP to INTERACT regularly and work on areas identified in survey.
